This year there will be a jury day JUST for current members as of Jan. 1st, 2014 on the 4th Sat. of April (April 26). This is your opportunity to become a displaying member, or to be juried in with another media. Look for the NEW forms in the docent desk notebook marked Forms. You will need both the Jury Process Application (Current Member) and the Jury Process Information form which shows you step by step what to do on submission day. Be sure to check out the NEW SCORING RUBRIC (on the form) that the judges will be using.

3 Proposals to be vote on at NBAL General Meeting, January 21, 2014

Proposal for Change of Responsibilities for 2nd Vice President

Explanation for changes: In past years the Special Shows Team Leader & Jury Process Team Leader jobs have both been done by the 2nd Vice President. Even if you had a team leader in these areas the 2nd Vice President has to be on hand to answer questions about the rules of jurying and special shows prospectuses, or oversee that all the paperwork involved in these events are done correctly. By changing the job description in the constitution/yearbook the responsibilities of the 2nd Vice President come in alignment with what the position actually does.

Propose that *Organizational Chart (page 5)* and *Job Responsibilities of Officers (page 38)* be changed for 2nd Vice President.

Job Responsibilities of Officers (page 38) should read:

Second Vice President will preside in the absence of the President and First Vice President. Manage and run Jurying Process and Special Shows, which includes the development of a jury/special shows schedule for the upcoming year by September of each year, up-dating all needed paperwork, and working with the Publicity/Advertising Team Leader to coordinate ads, notifications to other art organizations, and publicity for these events. Also includes coordinating with Treasurer and Membership Team Leader when needed as well as the appointment and management of Show Chairpersons, and Submissions Team Leader. Oversee and work directly with Submissions Team Leader, Reception Team Leader and Room Scheduling Team Leader. Provide all NBAL officers with up-dated information on newly juried members and winners of shows.

Proposal to Change the name **Special Shows Team Leader** to **Submissions Team Leader**

Explanation for changes: The job responsibilities of Special Shows Team Leader are now listed under the 2nd Vice President but there is still the need for a person to act as a contact between 2nd Vice President and the members of the Submissions Team. The Submissions Team already exists as an eight member team that works all the NBAL Special Shows and jury days, but is not documented in the constitution/yearbook. Replacing the name Special Shows Team Leader with Submissions Team Leader in the yearbook (Article V, # 30) would bring awareness to the fact that this team exists, and who their jobs should fall under in our organizational chart.

Proposal to change the name Special Shows Team Leader to Submissions Team Leader in the following locations:

NBAL Team Leaders – 2014 (page 6) – change Special Shows to Submissions Team

Article III, Section 4 (page 34) – change Special Shows Team Leader to Submissions Team Leader

Article V, Job Responsibilities of Team Leaders # 28, of the Constitution (page 44) - change Special Shows Team Leader to Submissions Team Leader

Job Responsibilities of Team Leaders (page 44) should read:

Submissions Team Leader will assist Second Vice President by coordinating the submissions team members with the jurying /submission day jobs; computer information input/double-checks, payment log sheet and money/change pouch, hangers to help co-chairs with artwork, door/handout paperwork and direct traffic. Also includes helping with of the computer and printer set-up, and collaborating with the special shows chairpersons in the planning of lunch for all submission day workers.
